Purpose of the Master's Program entitled "Financial Administration" (MP-FA), which is organized and operated by the Department of Economic Sciences, of the School of Economics and Management of the International University of Greece, in accordance with the provisions of Law 4485/2017 (Government Gazette A 114/4-8-2017, article 32) and Law 4610/2019, article 55, paragraph 10, is the deepening and promotion of knowledge in the subjects of Financial Management with the use of new technologies, the specialization of students in these and the formation of executives capable of responding to the professional field of businesses, organizations and the public sector and to promote the development of research and its applications in the aforementioned subjects. The MP-FA leads to the award of a Master's Degree in "Financial Administration".
